### YOUR RIGHTS AS A SUBJECT OF DATA

Minnesota Personnel Rules, Chapter 3900,6100, authorize the use of this number by the Minnesota Management & Budget (MMB).

Employees from Anoka Technical College may have access to your private data only if their work assignments reasonably require access during the hiring process. Others who may legally access the above data are representatives of the Attorney General and Legislative Auditor, enforcement agencies with statutory authority, and persons/entities authorized by law or court order.
